INTRODUCTION



Dear Friends,

The last few years have been groundbreaking in many areas, including philanthropy. 2021 was no different. Never before in Czech history had donors given so much money in such a short span of time. Via Foundation's fundraising drive for people affected by the June 2021 tornado in South Moravia raised \$10 million (CZK 250 million).

These difficult periods in society show why donors' long-term trust and support is so essential to non-profit organizations and foundations, including Via Foundation. The support infrastructure that we have been able to build over the years thanks to our donors allows us to respond quickly during crises and provide targeted and timely help. In this way we complement the role of the state or local governments. Another key element in turbulent times is the dense web of civic associations and engaged citizens across the country, which Via Foundation supports, once again thanks to donor generosity. When a crisis emerges, these associations typically transform their work overnight and begin doing whatever is needed at the moment in their communities — i.e., in hundreds of Czech towns and

villages. These engaged citizens are ready to assume responsibility and become important pieces in the mosaic of the system that we call democracy.

Via Foundation's endowment fund is a crucial source of stability for the foundation. The independence and revenue security that a well-invested endowment brings enables us to provide assistance quickly and strategically, whether in peaceful or unsettled times. Via's endowment campaign culminated in 2021 with the addition of CZK 19 million to this significant resource, thanks to the support of dedicated donors.

Another significant aspect of 2021 was the change in the composition of our Board of Directors. David Fojtík stepped down after six years of leadership and businessman and generous Via supporter Petr Kasa took over as chairman of the Board. Petr also led the endowment campaign.

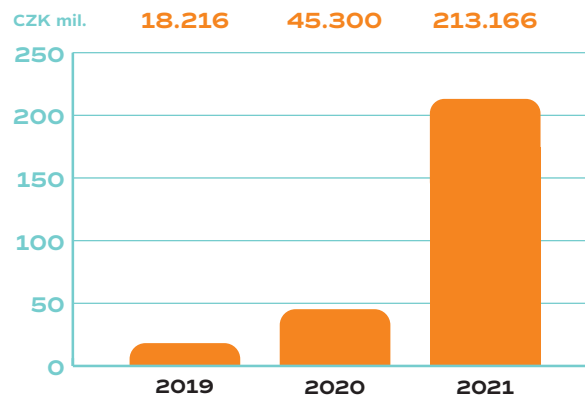

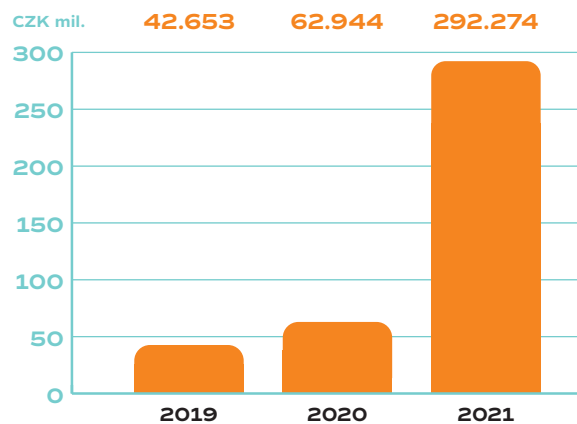

The Community in Which We Live



Every town has a heart — a vibrant place that is its core. Some beat steadily; in others it seems that all circulation has stopped. That's what we try to change. With this program, we support large projects that connect residents through collaborative efforts to improve a public space such as a park or village commons. The process begins with the community coming together to plan what they want the space to be. A landscape architect creates a design based on residents' input, residents play a large role in building and last but not least, they gather to celebrate their hard work. Of course, finding consensus among residents is often difficult. Alongside funding, we provide grant recipients with guidance through a community engagement specialist who helps residents in their efforts, workshops and site visits to see completed projects.

Residents Gather around the Community Bread Oven in Bílá Voda

Bílá Voda is a tiny village with 320 residents. It is a remote outpost in northern Moravia and yet it has a remarkable degree of diversity: one-third of the residents are Roma; there are also Poles, Slovaks and even one Frenchman. It has a hospital for the mentally ill, a retirement home and a pub even though it seems to be almost at the edge of the world. It is also known for the internment camp for nuns that the communists established here in the 1950s. Despite this complexity — or maybe because of it — the community seems to function well in Bílá Voda. With Via support, residents created a gathering place centered around a community bread oven.

"I had a long-term goal, or maybe more of a dream, to build an oven and fruit dryer. We managed to put together funding, we built the oven and the fruit dryer, but the area around them still wasn't very inviting. So we applied for a grant to fix up the site and make it into a proper gathering place with

a gazebo, outdoor kitchen and swings for children. What I like about Via Foundation grants is that they are awarded to projects that bring people together to work together."

Living Communities



The key to a positive neighborhood atmosphere and stability is relationships. We encourage people to take an interest in the public sphere, engage in improving neighborly relations, build trust, help make local communities more self-sufficient and deepen residents' relationship to the landscape. In addition to funding, we provide workshops, customized consultations, networking and the option of establishing a fundraising drive on our online giving portal, Darujme.cz, where we match the proceeds. Via's Living Communities staff also administers Česká spořitelna bank's program "We Can Do More" and in 2021 we also released a joint call to support regions still facing negative impacts from the Covid-19 pandemic.

IN 2021 WE SUPPORTED 261 PROJECTS WITH TOTAL FUNDING OF CZK 9 MILLION. CITIZENS CREATED E.G. 6 INTERPRETATIVE TRAILS, 12 COMMUNITY GARDENS, 14 NEIGHBORHOOD CELEBRATIONS AND 13 LANDSCAPE REVITALIZATION PROJECTS.

As documented by a Via survey, our comprehensive support enabled grantees to improve their:

- 88%** teamwork
- 67%** team management
- 78%** ties with local government
- 33%** ability to fund projects from a diversity of sources

Strolling through the Past in the Harta Neighborhood

Members of the Association for Harta in the town of Podhůří in the Vrchlabí mountains held a community event called “Neighbors through history and neighbors now”. The event featured an exhibit of local historical photos and involved neighbors and staff of the Krkonos Mountains museum.

Along with the exhibit, there was a booth where people could take pictures together and a neighborhood picnic. The aim of the event was to help residents learn about their roots, experience a fun day with neighbors and create interest in revitalizing the park in which the event was held.



Young Philanthropists



We support children and young people (up to the age of 26) to be stewards of their communities and help others. They are our Young Philanthropists. We believe that the sooner young people personally experience civic engagement and philanthropy, the greater the chance that they will grow into civic-minded adults. We provide funding, training and fundraising support to help them organize benefit events, neighborhood gatherings or landscape revitalization efforts. In 2021, the teams from 2020 continued in their projects, which included charity craft fairs, sports days, concerts and lectures.



A TOTAL OF 750 CHILDREN TOOK PART IN OUTDOOR COMMUNITY ACTIVITIES THROUGH 101 YOUNG PHILANTHROPIST MICROGRANTS. ANOTHER 157 CHILDREN AND YOUNG PEOPLE RAISED MONEY FOR GOOD CAUSES OF THEIR OWN CHOOSING. THEIR TOTAL PROCEEDS EQUALED MORE THAN CZK 523,000.

Teenagers Organized a Charity Children's Day Event

Thanks to Tereza, Helena and their friends, an open space at a housing estate in Hradec Králové became a vibrant play space for an afternoon.

There were games for children, a fire truck and a first aid demonstration. The proceeds from the children's day event were given to a local non-profit organization that helps victims of domestic violence. The gift of CZK 12,575 will enable the organization to buy toys for their youngest clients.



Young Stewards of the Landscape

A group of children from Mělník used a Young Philanthropists micro-grant to revitalize a vegetated bank among local fields.

The girls and boys cleaned up the area and planted new trees and shrubs. What led them to take on the project? They are well aware that vegetated banks and field borders are important ecological features because they support biological diversity, protect the soil from wind erosion and prevent soil runoff after rain.



Taking the Fear Out of Local Politics



45% of Czechs believe that they don't have a say in how problems are addressed in their town or city. To the contrary, we believe that a well-functioning municipality needs engaged citizens. In our program "Taking the Fear Out of Local Politics" we show participants how they can serve their community as elected officials.

IN THE SECOND YEAR OF THE PROGRAM, WHICH RAN UNTIL JUNE 2021, WE SUPPORTED 14 INDIVIDUALS CONSIDERING RUNNING FOR LOCAL OFFICE WITH TRAINING, MENTORING AND EXPERIENCE SHARING OPPORTUNITIES. IN THE THIRD YEAR, WHICH RAN UNTIL SEPTEMBER 2021, WE HAD 23 PARTICIPANTS.



"The program gave me much more than I expected. That's not to say that it completely erased my doubts and fears about engaging in the public sphere. But it did give me a set of building blocks (legal, financial, human resources) and a chance to learn from the experiences of experts from various fields and most of all, it connected me with other people who have set out on similar paths. Community Alphabet



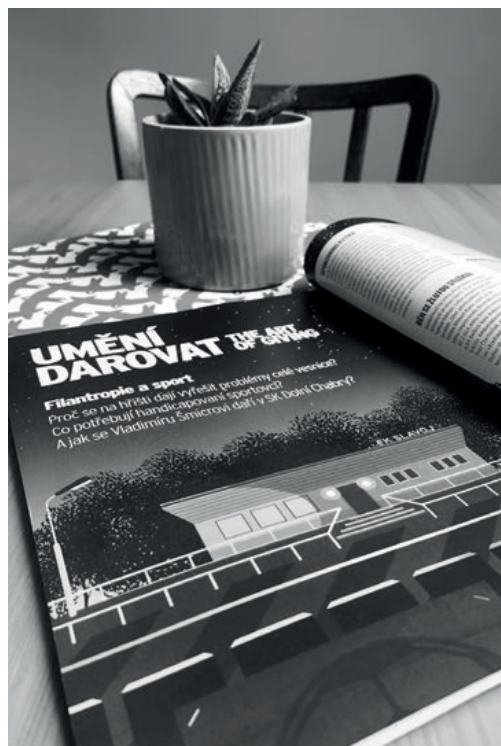
Broadening our horizons is an ongoing and essential process. We run a capacity-building program for people supporting communities in Hungary, Serbia and the Czech Republic — staff of foundations (including Via), professionals who guide communities in citizen engagement projects and community leaders. The focus is on learning about and applying asset-based community development (ABCD) approaches, which help communities identify, map and use their own resources and strengths. In 2021, 22 participants learned about ABCD from experts, were exposed to a variety of mapping approaches, advised one another and began piloting ABCD approaches in their own work. The learnings are helping Via improve its guidance of grantees by highlighting the resources they can find in their own communities.



The Art of Giving



Our “Art of Giving” journal has been helping us grow philanthropy in the Czech Republic since 2012. The journal shares articles about inspiring donors and supported groups, best practices in giving and interviews with interesting individuals. We also address aspects of philanthropy that are unpopular in Czech society, such as people on the margins or old age and death. In 2021, we also published a 100-page special issue that looked at philanthropy during the pandemic and new trends in giving. The Art of Giving journal is published quarterly as part of the magazine Reportér and is also available online on the Via website (in Czech only).



Via Bona Awards



The Via Bona Awards have been our way of recognizing inspiring Czech philanthropists and community “movers and shakers” for the past 24 years. During that time, we have received over 1,000 nominations, and awarded 140 individuals, companies and groups for their efforts. The 2021 theme was “Stories of Hope” and awards, which were accompanied by project grants of CZK 15,000, were bestowed upon:

Babeta Schneiderová — During the pandemic, Babeta helped find housing for homeless people in empty hotels. She also founded a running group called Advent Running, through which she has raised over CZK 1 million for families of disabled children.

Students for Oncology — The sad fate of a friend led this group of students to establish a fundraising drive for a young boy named Tomášek. They raised over CZK 100,000 to help him.

Nora Fridrichová — As a journalist, she has introduced issues around single mothers in public discourse. She has also acted as an intermediary for assistance to families into crisis.

Věra Fina — As the founder of the organization Jelimán, she has spent many years helping cancer patients and advocating for legislative changes to improve conditions for the disabled.

Věra Luhanová and Petra Zábranová — Using their own financial resources and volunteering their time, these two women set up a branch of the organization Nádech in Cheb to support single mothers. They offer material and psychosocial assistance.

František Kynčl — He has been helping homeless people since 2013 by involving them in regular volunteer clean-up days in the cities of České Budějovice and Tábor.



Darujme.cz



Darujme.cz, Via's online giving platform, has been connecting donors and gift recipients for over 10 years. It enables organizations, municipalities and institutions to register fundraising drives and donors to give securely with just a few clicks. We are well aware that safety, ease, simplicity and speed are crucial values in the online world. Continual technological development of Darujme.cz to make it an ever-friendlier tool for organizations and donors is one of Via's priorities.

It is a pleasure to see philanthropy grow and grow in the online world! Since the establishment of Darujme.cz, generous donors have sent more than **CZK 1 billion** to NGOs and other organizations.

In 2021 alone, more than 350,000 donors gave more than 950 NGOs a total of CZK 562 million. **The volume of gifts increased by 142% from 2020.**

Charitable Collection for Victims of the South Moravian Tornado



When a destructive tornado ripped through South Moravia and the Ústí nad Labem region on 24 June 2021, Via Foundation was one of first organizations to set up a charitable collection to help municipalities, families and communities. The wave of solidarity was enormous. Donors gave a total of CZK 248 million by the end of 2021.

To ensure just distribution of aid, we divided payments into several phases. Immediately after the natural disaster we sent funds to the five hardest hit municipalities and we also initiated coordination of aid with other NGOs. We disbursed over 75% of the collected funds by the end of 2021. We continue to help people in the tornado-struck areas through longer-term support for community revitalization.

In late 2021 and in 2022, our support has also focused on neighborhood initiatives and public space revitalization efforts. We are giving grants for reconstruction of community sites and collaborative efforts to restore vegetation or open spaces that involve as many residents as possible.

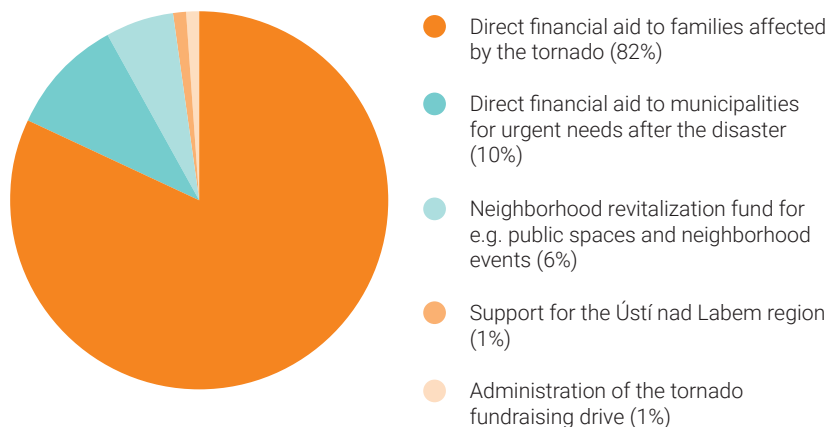

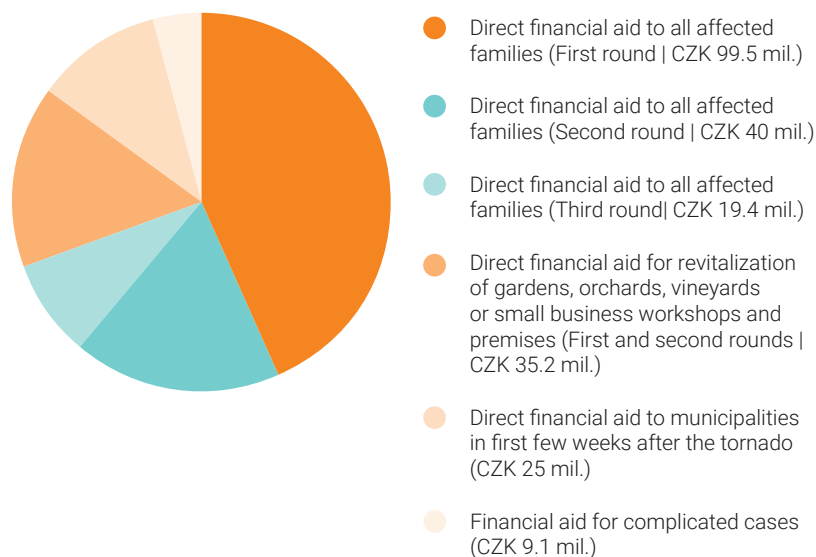

Partner Projects



Through partner projects, we offer our expertise to companies and donors who have their own philanthropic vision and would like to implement a community improvement project with our help. We take care of all the project administration for our partners.



T-MOBILE FUND

"HELPING THROUGH STORIES" EMPLOYEE CHARITABLE COLLECTION

Since 2013, the T-Mobile's Helping Through Stories employee charitable collection has been held every holiday season to support the company's employees' loved ones. At the end of 2021, T-Mobile employees nominated 20 individuals in crisis and supported them with a total of CZK 1,022,500. Half of the total gift was raised through employee contributions and the other half was given by T-Mobile. A total of 336 employees took part. The funds will help e.g. several children with severe genetic diseases or injuries and the family of an employee who died suddenly and tragically.

EUROWAG FUND

The company W.A.G. payment solutions established the Eurowag Fund at Via Foundation in 2018 to encourage charitable giving among its employees.

PHILANTHROPY & YOU

In 2021, every employee had the chance to take part in the project Philanthropy & You and give EUR 360 from the Eurowag Fund to any organization or individual in need in their community. Employees nominated projects using a special online application developed by Via. A record-breaking 663 employees participated and nominated 246 projects from 14 countries for support, which totaled EUR 238,680.



EMPLOYEE HOLIDAY CHARITABLE COLLECTION TO SUPPORT SHELTERS

W.A.G. payment solutions held the second annual employee charitable collection to support mothers and children in shelters. Through a collection on Darujme. cz, employees gave over CZK 40,000 and Eurowag rounded the total amount up to CZK 123,000. The proceeds were used to buy materials that were given to specific shelters.

TARGETED GRANTS

Four grants equaling a total of CZK 500,000 were also awarded from the Eurowag Fund to help people whose property was damaged by the tornado.

Y SOFT CSR FUND

Firma Y Soft was inspired by W.A.G. payment solutions' employee giving program and established the Y Soft CSR Fund at Via Foundation in 2019. In 2021, the organization Doctors without Borders was supported through the fund with a gift of almost CZK 100,000.

KAUFLAND "A MILLION FOR"... FUND

In 2021, the Kaufland "A Million For"... Fund was set up at Via Foundation to support positive neighborly relations in towns in which the company Kaufland opens a new supermarket. The company is donating CZK 1 million over a three-year period to support community and public space improvement projects in each such town. The first two grant calls — A Million for Olomouc and A Million for Rožnov — were opened at the end of 2021.



FOND ČERNOŠICE

In 2019, residents of the town of Černošice established a community fund at Via Foundation that promotes community building. Citizens contribute to the fund. This creates connections between donors and grant recipients who implement neighborhood initiatives in Černošice. In 2021, although the fund was still severely affected by the pandemic, 5 projects were supported with total funding of CZK 45,000. Support was given to a St. Martin's Day lantern parade and the association Pomoc od srdce ("Helping from the Heart"), which organized two holiday neighborhood events.

CZECH PHILHARMONIC BENEFIT CONCERTS

During the second year of the pandemic, we continued to organize charitable collections for hospitals with the Czech Philharmonic. We administered two Czech Philharmonic collections through Darujme.cz in 2021.

In March 2021, the Czech Philharmonic held a benefit concert to raise money to fund systematic psychosocial assistance for health care workers. The proceeds were given to the National Center of Nursing and Non-medical Health Care Professions for training of specialists who assist exhausted health care workers on site in hospitals. Individual, corporate and institutional donors raised a total of CZK 2.5 million.

A second benefit concert collection in May celebrating the 125th anniversary of the Czech Philharmonic raised almost CZK 2 million. The event partner and major donor, Škoda Auto, celebrated the same anniversary. The proceeds went to help survivors of social service workers who had died from covid-19 after being exposed to the infection at work.

TORNADO WINE

The RSBC group organized a series of “Tornado Wine” charitable auctions under the auspices of Via Foundation. The company purchased and auctioned off wines to support 6 small wineries in the towns of Moravská Nová Ves and Hrušky, whose vineyards, wineries and buildings were hardest hit by the tornado. The auction raised CZK 250,000 for the selected wineries.

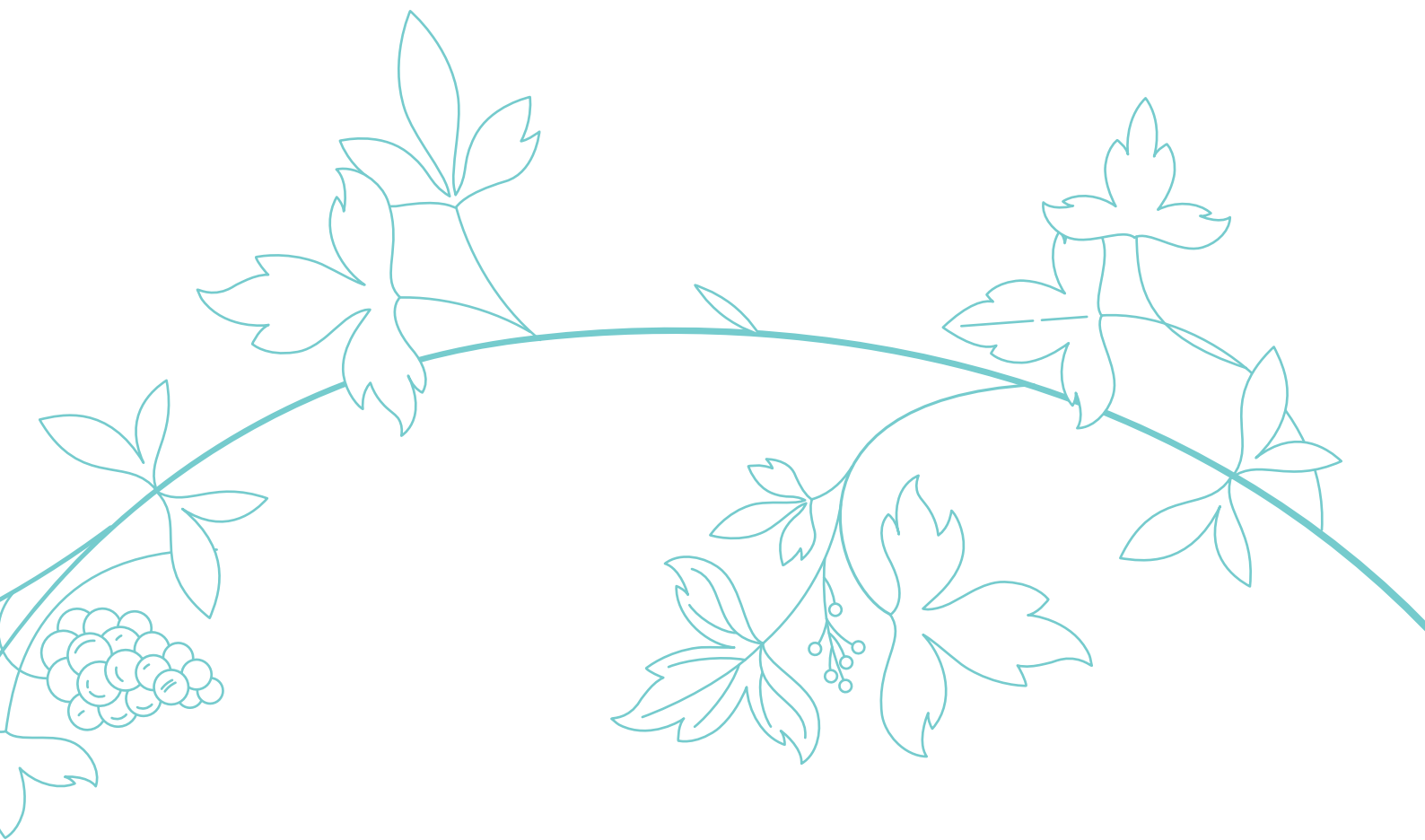

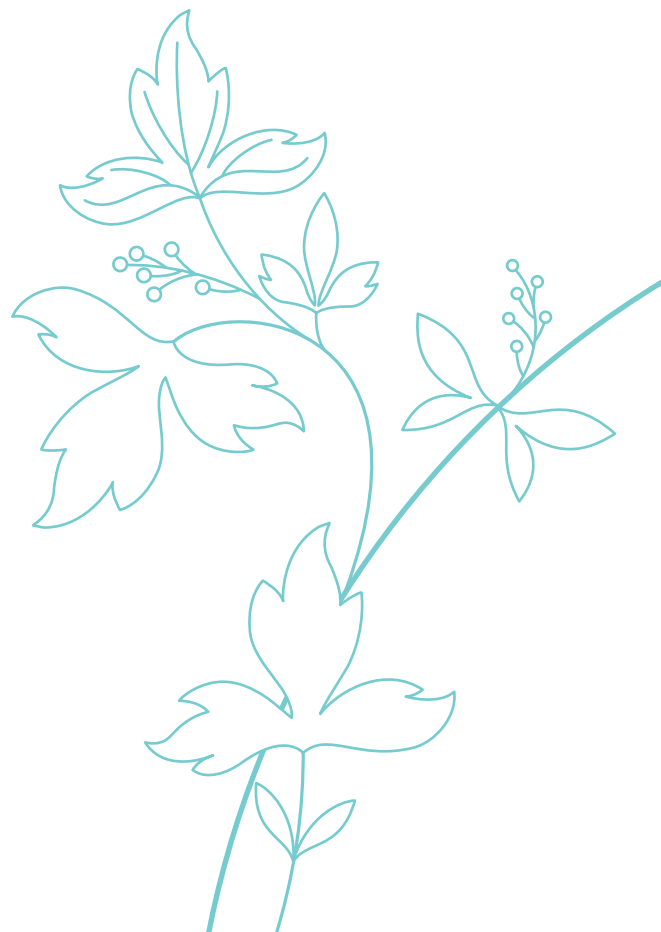

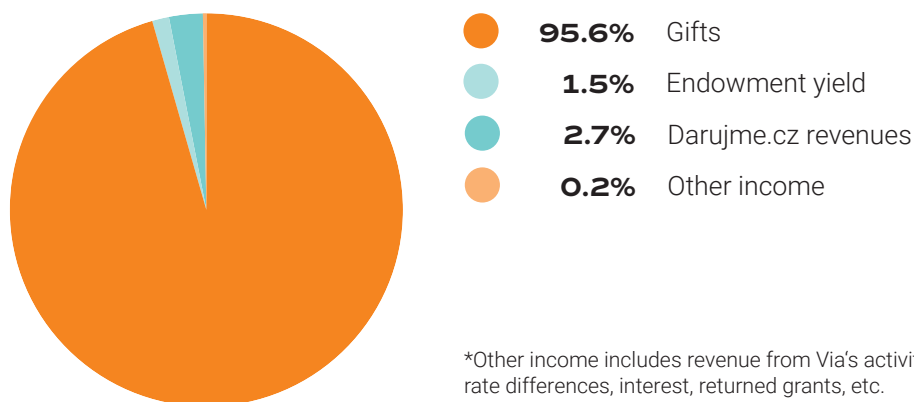

Composition of Via Foundation's Income in 2021

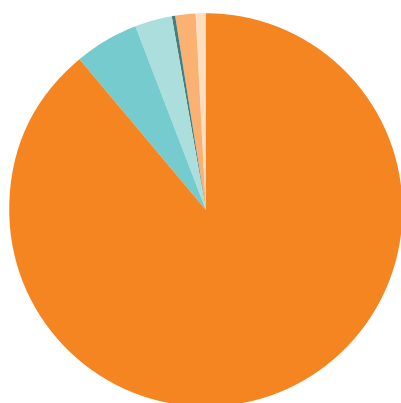

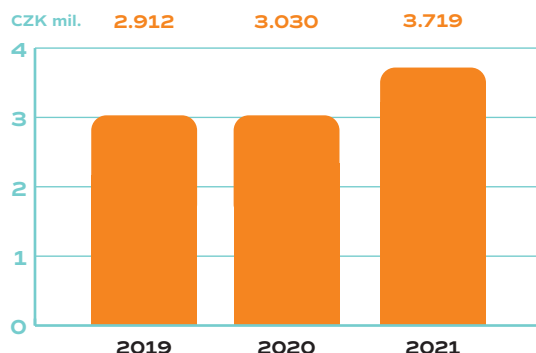

Investments without regular earnings aim to achieve capital appreciation of the given property. Via Foundation gains a capital return when selling these investments.

In 2021, net earnings from the endowment equaled **CZK 3,719,133, i.e. 5.2% p. a.**

The market value of the endowment registered in the foundation registry as of December 31, 2021 equaled **CZK 81,916,090**, which is **CZK 10,565,483** more than the value of the registered endowment.

The property was purchased for CZK 16,445,000 and this value is recorded in the accounting and reported on the foundation's balance sheet.

Zpráva o ověření účetní závěrky

Výrok auditora

Provedli jsme audit příložené účetní závěrky organizace Nadace VIA (dále také „Organizace“) sestavené na základě českých účetních předpisů, která se skládá z rozvahy k 31.12.2021, výkazu zisku a ztráty za rok končící 31.12.2021 a přílohy této účetní závěrky, která obsahuje popis použitých podstatných účetních metod a další vysvětlující informace. Údaje o Organizaci jsou uvedeny v bodě I. přílohy této účetní závěrky.

Podle našeho názoru účetní závěrka **podává věrný a poctivý obraz aktiv a pasiv organizace Nadace VIA k 31.12.2021 a nákladů a výnosů a výsledku jejího hospodaření za rok končící 31.12.2021** v souladu s českými účetními předpisy.

Základ pro výrok

Audit jsme provedli v souladu se zákonem o auditorech a standardy Komory auditorů České republiky pro audit, kterými jsou mezinárodní standardy pro audit (ISA), případně doplněné a upravené souvisejícími aplikačními doložkami. Naše odpovědnost stanovená těmito předpisy je podrobněji popsána v oddílu Odpovědnost auditora za audit účetní závěrky. V souladu se zákonem o auditorech a Etickým kodexem přijatým Komorou auditorů České republiky jsme na Organizaci nezávislí a splnili jsme i další etické povinnosti vyplývající z uvedených předpisů. Domníváme se, že důkazní informace, které jsme shromáždili, poskytují dostatečný a vhodný základ pro vyjádření našeho výroku.

Ostatní informace uvedené ve výroční zprávě

Ostatními informacemi jsou v souladu s § 2 písm. b) zákona o auditorech informace uvedené ve výroční zprávě mimo účetní závěrku a naši zprávu auditora. Za ostatní informace odpovídá správní rada Organizace.

Náš výrok k účetní závěrce se k ostatním informacím nevztahuje. Přesto je však součástí našich povinností souvisejících s ověřením účetní závěrky seznámit se s ostatními informacemi a posoudit, zda ostatní informace nejsou ve významném (materiálním) nesouladu s účetní závěrkou či s našimi znalostmi o účetní jednotce získanými během ověřování účetní závěrky nebo zda se jinak tyto informace nejeví jako významně (materiálně) nesprávné. Také posuzujeme, zda ostatní informace byly ve všech významných (materiálních) ohledech vypracovány v souladu s příslušnými právními předpisy. Odpovědnost správní rady a dozorčí rady Organizace za účetní závěrku

Správní rada Organizace odpovídá za sestavení účetní závěrky podávající věrný a poctivý obraz v souladu s českými účetními předpisy, a za takový vnitřní kontrolní systém, který považuje za nezbytný pro sestavení účetní závěrky tak, aby neobsahovala významné (materiální) nesprávnosti způsobené podvodem nebo chybou.

Při sestavování účetní závěrky je správní rada Organizace povinna posoudit, zda je Organizace schopna nepřetržitě trvat, a pokud je to relevantní, popsat v příloze účetní závěrky záležitosti týkající se jejího



nepřetržitého trvání a použití předpokladu nepřetržitého trvání při sestavení účetní závěrky, s výjimkou případů, kdy správní rada plánuje zrušení Organizace nebo ukončení její činnosti, respektive kdy nemá jinou reálnou možnost než tak učinit.

Za dohled nad procesem účetního výkaznictví v Organizaci odpovídá dozorčí rada.

Odpovědnost auditora za audit účetní závěrky

Naším cílem je získat přiměřenou jistotu, že účetní závěrka jako celek neobsahuje významnou (materiální) nesprávnost způsobenou podvodem nebo chybou a vydat zprávu auditora obsahující náš výrok. Přiměřená míra jistoty je velká míra jistoty, nicméně není zárukou, že audit provedený v souladu s výše uvedenými předpisy ve všech případech v účetní závěrce odhalí případnou existující významnou (materiální) nesprávnost.
